



Terms & Conditions

General

For the purposes of these Terms and Conditions, the "Promoter" refers to Teq and all related social handles of Teq. "Prizes" refers collectively to the three (3) prize options of a \$100 gift card, an OTIS branded JBL CLIP 4 speaker, and an OTIS branded YETI Rambler. "Entrant(s)" refers to any person who participates in the giveaway by following the entry steps below. "Winner(s)" refers to the three (3) selected Entrants that will receive one (1) of the three (3) Prizes.

By entering the giveaway, you agree to be legally bound by these terms and conditions. Any violation of the terms and conditions detailed herein will render an Entrant or Winner ineligible.

Contest Period

The giveaway opens 05/08/2023 and closes 05/12/2023. All Entries must be received by 5:00PM EDT on 05/12/2023.

Eligibility

- Contest is open to teachers currently employed in a K-12 public or private school in the United States except where otherwise prohibited or restricted by law.
- No purchase is necessary. Entrants will not be required to pay to enter the competition. The Winners will not be required to pay to claim a Prize.
- Entrants must be over the age of 21 at the date of their entry.
- Employees of Teq and their family members or employees of any affiliated companies and their family members are not eligible to win.
